I am pleased to present to you Niagara Community Action Program, Inc.'s annual report for the fiscal year of November 1, 2024 to October 31, 2025.



**MISSION: THE NIAGARA COMMUNITY ACTION PROGRAM, INC. IS A COUNTYWIDE AGENCY DEDICATED TO REDUCING POVERTY THROUGH A COLLABORATE EFFORT BY INITIATING AND CONDUCTING PROGRAMS OF SELF-SUFFICIENCY. OUR ULTIMATE GOAL IS TO EMPOWER INDIVIDUALS/FAMILIES TO REACH THEIR FULLEST POTENTIAL.**

The Niagara Community Action Program, Inc. is a private not-for-profit corporation organized under the membership Corporation Law of the State of New York with its original mission to serve the county of Niagara in developing, conducting, and administering a community action program as authorized by the Coates Human Services Reauthorization Act of 1998, PL105-285 superceded PL97-35 as amended and more specifically set in its certificate of incorporation.

The purpose of this organization is to effectuate within Niagara County the Economic Opportunity Act of 1964, as amended, and the Community Services Act of 1974 and the Omnibus Budget Reconciliation Act of 1981 in order to initiate, strengthen, supplement, and coordinate efforts to eliminate poverty by making available to the poor opportunities for education and training, employment, and other services designed to aid them in their struggle against poverty.

In furtherance thereof, this agency shall:

- A. Encourage the development of programs designed to eliminate poverty by proposing and conducting such programs in Niagara County.
- B. Develop research and evaluation procedures in connection with the anti-poverty programs conducted or funded by the agency.
- C. Contract with other agencies for the conduct and administration of community programs.

1966 - 2025

Milestones in the Agency's History

1960s

- Incorporated October 31, 1966.
- Operated Head Start Program in Niagara County.
- Niagara County Legal Aid Society was a delegate agency (through May 1, 1973 when it became directly funded by O.E.O.).
- Niagara Community Action Program, Inc. Social Service staff provided Social Services counseling.
- Credit unions established as area centers.
- Falls Products, Inc.--Economic Development Project--1968.

1970s

- Youth Development Program
- Family Planning Program funded under HEW--this program was transferred to the Planned Parenthood Association in April 1974.
- Community Alcoholism Program
- Emergency Food and Medical Services
- Head Start--1966--operated through March 1976.
- Manpower Program for Niagara County youth under age 25
- February 1973--three bus loads from Niagara Falls participated in the Mobilization at Washington, D.C.--the purpose of which was to bring to the attention of the President and Congress the need for the continuation of the Poverty Program.
- Summer Food Program for children provided through grants from the U.S. Department of Agriculture--- 1974-1981.
- Multi-Purpose Centers: \*LaSalle, Lockport, \*East Side, \*Niagara Street, and \*North Ends (all located in Niagara Falls)--advisory council at each center--basic services: nutrition, cooking classes, consumer education, sewing, consumer homemaking and health care classes--outreach and referral is central to the centers' activities.
- Each center's programs:
  - East Side Multi-Purpose: parent skill workshop, prenatal health care, summer youth programs at Artpark.
  - LaSalle Center: utilized LaSalle Recreation Facilities for programming--baton classes and parent/child playroom which allowed parents to participate in programming who otherwise would be unable to attend because of child care needs.
  - Lockport Center: transportation from rural areas to hospitals, health care facilities, and other agencies for services--upholstery classes, first aid classes, and youth field trips.

1970s (continued)

Niagara Street Center: adult education and high school equivalency classes, English and citizenship classes.

North End Center: dealt with employment and neighborhood improvement projects--senior citizen programming.

- Under C.E.T.A. (Comprehensive Employment and Training Act 1973), Niagara Community Action Program, Inc. created: Community Health Education Program, Senior Citizens Transportation Program, Publicity Program, and Human Services Research Program.
- Youth Bureau funding provided for Drop-Out Counseling Program.
- Office for the Aging (Niagara County)--three day care centers for elderly.
- Mobilization Day in Washington (CSA) to replace the Office of Economic Opportunity under which Niagara Community Action Program, Inc. originally operated.
- Countywide Human Services Directory was completed in July 1975.
- During Blizzard of 1977, Niagara Community Action Program, Inc. operated: Special Crisis Intervention Program--provided special assistance for fuel bills to nearly 1,500 eligible persons, and the Energy Crisis Intervention was conducted for families suffering undue hardship due to excessive heat bills, frozen pipes, lack of food and blankets, etc.--1,672 persons received services which included emergency fuel, repairs, blankets (100 senior citizens), and food (395 families).
- 1977/1978--opened new neighborhood center--Evershed Center on 56th Street in Niagara Falls.
- 1977/1978--Emergency Energy Assistance Program--provided fuel payments (operated through 1981).
- 1977/1978--Niagara Community Action Program, Inc. entered into delegate agency contracts with the following: Cooperative Extension Association to develop and organize urban 4-14 clubs in the City of Niagara Falls; Niagara Falls Boy's Club to provide an informal drop-in center, formal group activities, and special interest groups for youth; and the 13th Street Multi-Purpose Center to provide educational, social, and recreational activities for East Side youth.

## 1980s

- Continuation of Neighborhood Center Program, Alcoholism Program, Weatherization Program, Senior Citizen, and Youth Program in 1980s.
- WIC (Women, Infant, and Children Program) 1980-1985--provided nutrition education and supplemental food for eligible women, infants, and children.
- HEAP (Home Energy Assistance Program) 1980-1981.
- Countywide recreational youth programming (1981-1986) focusing on fun and learning trips and individual and career development through Project Pathfinding, Open Horizons, and Self-Imaging programs.
- ECIP (Emergency Crisis Intervention Program) provided furnaces for eligible clients--1982-1983.
- TAP (Telephone Assurance Program) provided special "linkages" to homebound senior citizens through prearranged phone outreach.
- Emergency Food and Shelter Program 1983-present--provided food and shelter vouchers on a one-time-only basis to persons in an emergency situation.
- 1985--Niagara Community Action Program, Inc.'s Board and agency participated in extensive letter-writing campaign to elected officials at national level which led to allocation of CSBG funds in 1985 and approval of the Human Service Reauthorization Act of 1986 which provides for four more years of community action, low-income energy assistance, Head Start, and other essential programs.
- Dislocated Worker Program 1983-1987--provided employability skills training, vocational counseling, remedial education, human service assistance, and job placement to certified dislocated workers.
- Rural Preservation Program 1986-present--provides housing preservation and community renewal to low-income homeowners and renters in rural Niagara County.
- In 1987, awarded Affordable Housing Grant--to provide home improvements to ten qualified residents in the Town of Porter to be implemented in 1988/89.
- Niagara Community Action Program, Inc. received (1987) \$10,000 grant from the Town of Porter to target special projects in that town and/or be used in conjunction with the Affordable Housing Grant.
- 1987--received an additional \$100,000 from the N.Y.S. Department of State/Division of Economic Opportunity/Department of Energy for Niagara Community Action Program, Inc.'s Weatherization budget up to approximately \$550,000--the largest amount of money in the program's history.
- Opened neighborhood center (1987) at the Rainbow Senior Citizen Center at 2818 Highland Avenue, Niagara Falls, New York.
- Countywide Niagara Community Action Program, Inc.'s Human Services Directory published in August 1987.

1 9 8 0 s (continued)

- Implemented blow-in insulation into brick homes in the Weatherization Program (1987). Niagara Community Action Program, Inc. was the first agency in Western New York to implement this procedure.
- In October 1987, Niagara Community Action Program, Inc. purchased the former M & T Bank building at 1521 Main Street, Niagara Falls with intentions to remodel it and house its administrative offices and headquarter its programs.
- Received a \$50,000 Community Development Block Grant from the City of Niagara Falls/Office of Community Development as one-third of the total purchase and renovation cost for the bank building (1987).
- Received a funding reservation from the Division of Housing and Community Renewal for \$99,217 toward the renovation for Niagara Community Action Program, Inc.'s new administrative office building.
- Began implementation of a countywide needs assessment targeting the poor. Niagara Community Action Program, Inc. held 15 community meetings throughout the county that provided the county's poor an opportunity to express their concern. Areas of need were defined in child care, transportation, and employment.
- Administered a countywide free smoke detector and light timer program.
- Organized a Minority Area Council/Consortium of local area businesses/churches, etc. in Highland Avenue community.
- Administered a Job Training Program and Area I Neighborhood Preservation Corporation targeting minorities in the Highland Avenue community. The success rate has been high enough to continue the program in 1989.
- In 1988, opened two new neighborhood centers in the northeastern areas of the county; Barker and Olcott, New York.
- Received an entitlement grant from CSBG under the Stewart B. McKinney Act funds to administer a housing assistance program for the homeless in the county.
- In 1988, Niagara Community Action Program, Inc. was designated by the Legislature as the County's Fair Housing Advocate. Designed and developed a program and trained staff in the areas of fair and equal housing.
- 1989 Grants applied for and obtained:
  - \*Federal Emergency Management Agency - \$2,458
  - \*Rural Homeownership Assistance Program - \$29,746
  - \*Public Service Commission
  - SAVINGPOWER Program - \$4,900
  - \*NYS Office for the Aging - \$20,000
  - \*Town of Porter - \$10,000
  - \*Rural Area Revitalization Program - \$65,065
  - \*Emergency Homeless Program - \$20,529

## 1980s (continued)

- \*Niagara Council of the Arts - Video Grant - \$1,000
- \*Supplemental Nutrition Assistance Program - \$1,895
- In 1989 obtained sponsorship from USDA to administer meal reimbursement to licensed Home Day Care Providers.
- Subcontracted with National Fuel Gas Corp. to: 1) insulate 25 homes of HEAP-vouchered recipients and 2) perform 309 energy audits under the SAVINGPOWER program.
- Wrote a \$5.7 million grant to the Affordable Housing Corp. to build over 200 new homes in scattered sites throughout Niagara County. Grant approval is expected in the early part of 1990.

### **OVERVIEW**

The Niagara Community Action Program, Inc. is part of a nationwide network of private, not-for-profit, human-service agencies which address the needs of the poor. It is part of a statewide network of community action program (CAP) agencies and regionally is one of the seven CAPs located in Western New York and the Southern Tier. Indeed, it is difficult to find an area of the country that has not been touched by the efforts of community action.

The community action agency in Niagara County was incorporated October 31, 1966. At that time, it was designated by the Niagara County Legislature as the county's official anti-poverty agency. As such, the agency serves the entire county from its neighborhood centers in North Tonawanda, Lockport, and Niagara Falls. The administrative offices and the programs are headquartered at the 1521 Main Street location in Niagara Falls.

The agency currently operates with a 31-member staff, supplemented by volunteers. Members of the senior administrative team have exceptional credentials and track records. Sole responsibility for governing the agency rests with its 15-member Board of Directors.

Niagara Community Action Program, Inc.'s income level for clients ranges from the middle income to the indigent poor. Niagara Community Action Program, Inc. provides services to a needy population that includes the working poor, the elderly, the disabled, minorities, veterans, single heads-of-households and their dependent children, adolescents, youth, disabled, etc.

Niagara Community Action Program, Inc. is an integral part of the human-service network in the county--going far beyond, but not duplicating, the efforts of any other human-service agency.

The agency is federally funded through the New York State Department of State, Community Services Division, Community Services Block Grant Program. A large portion of the remaining funding is additional federal funding and state funding from various funded agencies (i.e., Homes and Community Renewal, Office of Children and Family Services, Hunger Solutions New York, New York State Affordable Housing Corporation, etc.). The balance is local municipality, county, and town funding.

In generating programming for the target population, Niagara Community Action Program, Inc. is guided by two major objectives: (1) to improve the quality of life of low-income families, and (2) to provide them with opportunities that will lead to self-sufficiency and greater knowledge of self. In the sections that follow, a brief description of existing programs is provided.

- minor roof repairs
